**II. The UN seeks experts to participate in an international symposium on ocean science-policy**

The Division for Ocean Affairs and the Law of the Sea (DOALOS), United Nations Office of Legal Affairs, as the Secretariat for the Regular Process for Global Reporting and Assessment of the State of the Marine Environment, including Socioeconomic Aspects (Regular Process) in collaboration with the Intergovernmental Oceanographic Commission of UNESCO (IOC-UNESCO) solicits the nomination of experts to participate in an international symposium of the United Nations Regular Process on strengthening the ocean science-policy interface. The symposium will be held at IOC-UNESCO Headquarters in **Paris, France**, from **12 to 13 December 2023**.

Experts who are nominated or wish to nominate themselves are kindly invited to fill out the [online application form](#).

Nominations should have due regard to the need for gender balance. Funding will be provided by the United Nations (economy class round trip flight ticket and Daily Subsistence Allowance) for the selected experts, with priority given to experts from developing countries.

The deadline to submit an application is **20 October 2023 5 PM EDT**.
